Recruitment

Admission requirements and the profile of candidates

Course is designed for current students of all years as well as university graduates. This well-tailored program is created for candidates coming in with legal, business, international relations and political science backgrounds.

Language skills: English (B2)

- ✓ The candidates are **not required** to provide a language certificate. The School takes no responsibility if the language capabilities of the candidate are not sufficient.
- ✓ Knowledge of Chinese is **not required** for the course. The school asks for the level of Chinese in order to adjust the classes to skills possessed by the candidates.
- ✓ Legal knowledge is **not required** for the course. Legal background will be an additional advantage.
- ✓ Experience related to China is regarded as desired but not obligatory.

Tuition fees

Students: 2 500 PLN / semester

Professionals: 3 500 PLN / semester

Tuition is to be paid by 15th July. Tuition can be split into two installments. Second installment can be paid up until the beginning of the summer semester. The School does not offer scholarships.

Participants of the School might apply for an interest-free loan supported by the Polish government. Upon graduation students granted such loans might be subjected to a 25% discount. For more details, please visit www.inwestujwrozwoj.pl.

Wait for the admission decision until 1st July.



Pay the tuition fee in total or the first installment, within 14 days from receiving the admission letter.

Note: Special conditions for application might be offered to partners and sponsors of the School as well as public institutions. The School reserves the right to organize a second round of application if deemed necessary.

Curriculum

The programme will be based on three pillars: legal, social/economic and language.



The legal pillar

Students of the School will participate in courses discussing aspects of Chinese law, including civil, corporate, constitutional, administrative, criminal, arbitration and commercial law, as well as the law governing intellectual property and foreign investments, plus the Chinese judicial system.



The social-economic pillar

Students of the School will participate in workshops on the political system of the People's Republic of China, the China's model of economic growth, doing business in The Middle Kingdom, contemporary social/cultural issues as well as institutional cooperation with Chinese partners.



The language pillar

Students of the School will have the opportunity to start or continue studying Mandarin Chinese. Experienced teachers will deliver practical courses including elements of business and legal language.

Lecturers

The lecturers will include:

1. Chinese professors of law or economy from the most prominent universities and other academic institutions, such as Peking University, Chinese Academy of Social Sciences, China University of Political Science and Law, BFSU,
2. Chinese practitioners (lawyers, public officials);
3. Experienced professionals from Europe with vast experience on Chinese market.

Graduation requirements

Attendance: 2 unexcused absences per semester

Mode of studies: Classes are held on weekends. The classes start at 9 a.m. and finish at 6 p.m. (including facultative classes). Optional classes might be organized during weekdays. During such, attendance is not mandatory.

Exams: One exam per semester based on the topics taught during the semester.
