OVERVIEW: POLAND & CHINA

Our project is a part of developing and strengthening relations between Poland and China, especially in the area of economy. Both countries are implementing policies of deepened cooperation and partnership to benefit from mutual interests.

The aforementioned cooperation is not a mere declaration, but an actual project that aspires to be a part of the Belt and Road Initiative. This initiative shows that China sees Poland as one of the fastest-growing economies in Eastern Europe, with whom a working relation is indubitably a profitable prospect.

Cooperation between Poland and China is not limited to a governmental partnership, but it also flourishes between Polish local governments and Chinese provinces, for instance Łódź and Chengdu. This cooperation takes place mainly amongst the countries' companies:

In 2018 Polish Investment & Trade Agency opened two new offices on Chinese soil - in Chengdu and Hongkong.

The Agency also aided establishing AI research & development centre of TCL Corporation (集团) in Warsaw. Other Chinese corporations that chose Poland are Nuctech (威视股份), which also opened a R&D centre in Warsaw, and Guotai Huarong (国泰华荣) that will build electrolyte factory in Lower Silesia Voivodeship.

Polish enterprises regularly appear at China Import Expo and present great interest in entering the Chinese market. The Port of Gdańsk opened its office in Shanghai in order to promote investments in Poland and their own services in area of logistics.

In 2016 the Republic of Poland and the People's Republic of China signed a treaty concerning recognition of graduation diplomas, which caused a growth in the number of Chinese students at Polish universities. According to the Ministry of Science and Higher Education data, there were over 1700 of them in 2018.



MAIN IDEA OF THE PROJECT

Warsaw-Beijing Forum is a project organized by the Students' Organization for Law and Economy of China. The major focus of the organization is to establish a strong, multidimensional connection on the line China – Poland, particularly between students from China University of Political Science and Law and the University of Warsaw. The goal is to give the participants an opportunity to acquire knowledge and experience during a series of lectures, meetings and workshops led by renowned experts. It promotes international cooperation among young professionals from the two countries. In order to build a strong liaison between future leaders, the Forum focuses on the exchange of knowledge and experiences regarding both business and culture, hence aiming to develop entrepreneurship and mutual understanding between the nations. In conclusion, our purpose is to impact international business, trade and partnership of both countries. We strive towards the world of coming together, of building bridges.

WARSAW-BEIJING FORUM 2018

The Fifth Edition of the Project

Edition V of our project was yet another Victory and tremendous success.

The project showed that Poland has much to offer as a country of developed legal tradition, which makes it a good place for business. Furthermore, it allowed both parties to gain inspiration from one another in terms of legal solutions. The events held during the Chinese part of the Project confirmed that China is currently the leader in developing new ideas, which are crucial for us to face the challenges of the fast-evolving society and the economy of the modern world. The Chinese students gained knowledge that could prove useful in facilitating Chinese investments in Poland and the CEE region, whether they decide to provide legal service to enterprises interested in investing or try their hand at creating their own business projects in our country.

We promoted Poland as a place where innovative business flourishes. Moreover, the activities of the Fifth Edition were also focused on overcoming cultural barriers arising from vast differences between the students' cultural backgrounds. Many events, such as visits to famous museums, deepened the participants' understanding of the both countries' fascinating histories. The mutual appreciation of great cuisine and marvellous cultural sites of Poland and China definitely brings the participants together, despite the thousands of kilometres that divide them. This year's edition was enriched by a visit to Hong Kong, where the students met with the Consul General of the Republic of Poland - Mirosław Adamczyk.





THE WARSAW PART

The first part of the Project was held in Warsaw between 23rd and 27th of April 2018. The short stay in the Poland's capital was a very busy one – the participants attended as many as 23 meetings. The topics ranged from the theoretical and procedural aspects of the Polish and European law, through international M&As, ending with Polish cuisine. The broad spectrum of discussed issues allowed the Chinese students to gain a broad understanding of not only Polish law and economy, but also culture and traditions.

THE BEIJING PART

The second part of the Forum took place between 26th of October and 9th of November 2018. The participants gained knowledge of the framework and institutions of the Chinese judiciary during fascinating lectures held at the Supreme People's Court of China. Furthermore, thanks to the visits in various law firms located in Beijing, they had an opportunity to learn about the ins and outs of practising law in China. The meeting and a lively discussion in Sina.com headquarters provided an insight into the daily operation of one of the most successful so called Chinese unicorns.

ACHIEVEMENTS: FIVE YEARS OF WARSAW BEIJING FORUM

Over the course of the past five years, Warsaw-Beijing Forum has changed significantly. It all started from a small students' organization. Nowadays, it is the biggest and the most successful students' project in the field of Sino-Polish relations. It is also one of the best students' projects at the whole country's scale. The main idea of the project describes our vision for the future relations between Poland and China. Now, we're extending that vision with the tremendous experience we have gathered over the previous editions of the Forum. The past five editions were an uncompromising success. We organised many thought-provoking conferences, tailor-made workshops and fascinating lectures to plant new ideas in the minds of our participants. We were not only focused on their self-development, but also on training future specialists that will work for the sake of Poland and China.



The Warsaw-Beijing Forum was nominated for the best students' organization in multiple contests and got a number of grants for its operations. It attracted extensive media coverage in nationwide internet portals and newspapers like Rzeczpospolita, Interia.pl or Forsal.pl.

What is more, it took place under many honorary patronages, including those from some of the most prominent public figures, such as the President of Warsaw, Hanna Gronkiewicz-Waltz or President of Poland - Andrzej Duda.



Warsaw-Beijing Forum has also been awarded a grant from the Ministry of Science and Higher Education. The award allowed Warsaw-Beijing Forum members to organize the First Polish Academic Conference on Legal and Tax Issues of Trade between Poland and China. The event gave the listeners a chance to take a deeper look into one of the most important and intricate aspects of the Sino-Polish relations - taxation issues and tax law.

The founders of the project, using the invaluable experience gathered during the first steps and the evolution of the Forum went on to create the School of Law and Economy of China in Warsaw. Established at the Faculty of Law and Administration of the University of Warsaw, the school hosts professors, lawyers and experts from China, Poland, Europe, Russia and the U.S. in order to build up knowledge about the Chinese legal system, economy, culture, and language. The school's curriculum is designed not only for students, but also entrepreneurs and administration representatives who wish to broaden their knowledge about China and establish relationships.



THE OPENING CONFERENCE OF THE WARSAW PART

Monday, April 23rd 2018



The Opening Conference of the Fifth Edition of Warsaw-Beijing Forum took place in the Senate Hall of the Kazimierzowski Palace, one of the most beautiful neoclassical buildings in the city. Apart from the participants of the Forum from Warsaw and Beijing, the conference was also attended by the representatives of partner universities, diplomatic corps, partners, and sponsors.

The Conference consisted of official opening speeches given by:

Prof. Tomasz Giaro - Dean of the Faculty of Law and Administration,

Prof. Piotr Taracha - Dean of the Faculty of Oriental Studies,

Dr Liu Xiaobing - Representative of China University of Political Science and Law,

Dr Piotr Grzebyk - Academic Guardian of the Forum,

Mr Artur Siejka - former associate at Trade & Investment Section of the Embassy of Poland in Beijing.

Each one of the speakers took the opportunity to share their invaluable knowledge and experience with the attendees, for which they were thoroughly grateful, which could be seen from the number of questions asked and the loudness of the applauses.





Monday 23rd/Tuesday 24th



TRINITY CULTURE LAB

The lecture focused on a matter essential for understanding Polish society both past and contemporary: the values of the nobility (called szlachta in Polish) and its relations with the commoners. After a short introduction to the topic, Mr Piotr Frankowski, an expert from the Trinity Culture Lab, described the historical events which had a major influence on the Polish Commonwealth's evolution into a modern society. Later on, the participants had the possibility to broaden their knowledge of the legal aspects of successive republics established by the Poles after several major turns in the nation's history.

STARTUP HUB POLAND

During the meeting with Startup Hubrepresentative, the attendees had an opportunity to become familiar with Polish start-up environment. The meeting revolved around obstacles and opportunities related to a business foundation in Poland. The speech was strongly rooted in the lecturer's experience obtained in Startup Hub and was a very valuable advice.





CRUISE ON VISTULA RIVER

Thanks to the generosity of Warsaw Tourist Office, the students took a cruise on the Vistula river. That was an extraordinary chance to admire the breath-taking view of the city's skyline lights reflections on the still Vistula waters. The scenery inspired the participants to share their impressions and get to know each other better.

SUPREME ADMINISTRATIVE COURT

The visit to the Supreme Administrative Court consisted of two parts: In the first, one of the judges presented an outline of Polish juridical system and underscored the crucial role of the Court within it. During the second part, the participants were given a unique opportunity to tour the building, including a visit to a court hall and library. The Beijing team was eager to ask a plethora of questions concerning the Court's position in the judiciary system and judges' competences. Ultimately, a lively discussion arose regarding the question whether such a complex court division system is effective.



TUESDAY 24th



KUKE

During the lecture conducted by KUKE's representatives the participants had the honour of admiring the historical building of Poroczyński Gallery. Surrounded by masterpieces of Pierre-August Renoir, Vincent van Gogh or Salvador Dali displayed in the magnificent interiors, students were introduced to the company's operations, mainly those concerning export insurance backed by the State Treasury.

SDZLEGAL SCHINDHELM

The case study, prepared by Dr Agnieszka Łuszpak-Zając, concerned conducting business in Poland, mainly trade agreements and the contractual clauses. A crucial part of the meeting was teamwork - the participants were divided into four groups, with each working on a different issue. It allowed the members to deepen their understanding of the provisions typical for Chinese partners and possible obstacles and opportunities of the cooperation between Poland and China. The participants were able to gain knowledge of international contracts, possible risks, and processes of defining the key provisions. The speaker also clarified how SDZ Legal works with its Chinese partners.





OPEN MEETING WITH PROFESSOR BOGDAN GÓRALCZYK

Professor Góralczyk along with his audience embarked on a voyage to answer the question: "Is China ready for the global leadership?". The discussion revolved around geopolitical and economic landscape of the world we live in. Chinese guests were in awe of the speaker's vast knowledge of various intricate aspects of China and were eager to engage in a discussion. Moreover, the guests had the chance to learn about the professor's newest publication called "The Great Renaissance: Chinese Transformation and its Consequences" in which he presents China's road to regaining its position as a world superpower.

WEDNESDAY 25th



POLISH INNOVATIVE MEDICAL CLUSTER PIKMED

Mr Tomasz Szelągowski - President of the Board of Polish Innovative Medical Cluster delivered a lecture focused on how the technology impacts modern medicine. The lecturer's main objective was to raise the participants' awareness on the subject of urgent changes in the healthcare legislative system, e.g. the need to allow for conducting medical examinations and filing prescriptions via the Internet. Mr Szelągowski also presented the differences between Chinese and Western medicine, enumerating both the advantages and disadvantages of each; he also talked about how knowledge and joined use of the two can prove effective

COURT OF ARBITRATION AND THE POLISH CHAMBER OF COMMERCE IN WARSAW

On the third day the participants were invited to the Court of Arbitration and the Polish Chamber of Commerce in Warsaw - major permanent arbitration in Poland. Students had an opportunity to learn about alternative dispute resolutions and get an insight into the Court's arbitration rules. After a brief presentation students took part in a Q&A panel on differences in the role of arbitration in Poland and China.



THE CONTRACT OF THE CONTRACT O

ENERGY REGULATORY OFFICE

The following event was hosted by the Energy Regulatory Office. The topics included discussion on administrative regulations, fossil fuels and renewable energy sources. The discussion was powered by our Chinese guests' profound interest in the energy sector nuances. One of the most interesting observations made during the discussion was that both Poland and China have to embrace renewable energy sources as an indispensable tool for a greater future.

OPEN LECTURE BY MR TOMASZ KRZEŚNIAK FROM KRZEŚNIAK-BUDZYŃSKI-STEC LAW FIRM

Attended not only by participants of our project but also many guests from the outside, the lecture was very well received. Mr Krześniak introduced the core ideas of Sino-Polish economic cooperation alongside with intricate details of Polish goods' export. Despite the fact that the lecture took place in the great Old University Library main hall, no seat was left empty.

THURSDAY 26th



MEETING AT THE EMBASSY OF THE PEOPLE'S REPUBLIC OF CHINA

The highlight of the fourth day of the Forum was visiting the People's Republic of China Embassy in Poland - a rare honour. First, the participants attended a screening of a video material presenting newest, state-of-the-art achievements of Chinese industry. Later the group visited the Embassy's gardens - an astonishing landscape in the very heart of the city, full of blooming flowers and traditional Chinese pavilions. The guests had a unique opportunity to witness with their own eyes how the diplomatic corps representatives live.

PwC POLAND

Ms Helen Qin, a senior associate at PwC's Hong Kong's branch, currently residing in Warsaw delivered an inspiring, thought-provoking workshop on M&As in Hong Kong. Given her career path, she explained how one can combine and work within two such different legal and economic systems, as Polish and Chinese surely are. Participants actively worked in groups, engaging in real-life problem solving tasks. They learned about the benefits of being a multi-dimensional worker, with knowledge across many fields, whose combination can prove tremendously useful.

PIEKUT ADVISORY

Maximilian Piekut, one of the founders of Warsaw-Beijing Forum, currently a deputy director at Polish Research Centre for Law and Economy of China spoke about opportunities and possible obstacles of investing in China. Moreover, he emphasized the crucial role of Polish-Chinese business relations. The attendees gained invaluable knowledge about possible way of capital locating from a real-life expert.

MAGDALENA PSZCZÓŁKA'S OPEN LECTURE

Ms Pszczółka, an expert working in LOTOS, a leading Polish crude oil industry company, and an associate at the University of Gdańsk delivered a lecture strictly connected to her working experience. Namely, she spoke about the still actual importance of fossil fuels, despite the current tendencies towards renewable energy sources. She highlighted that even though we have to strive towards energy solutions which are better for the environment, we have to acknowledge that the process of the change has to be well-planned we cannot just abandon oil or gas right away.



Friday 27th



ICBC WARSAW BRANCH

This visit provided a great, unique insight into the world of great business banking industry. The visit consisted of three parts, namely:

- 1. A visit to the amazing headquarters in a historical building located in the very heart of Warsaw.
- 2. A lecture developed by a true role model of every participant Tomasz Janyst, the Deputy Head of Legal and Compliance Department at ICBC. He shared his expertise and experience while presenting given issues of the newest banking regulations in China.
- 3. In branch discussed with ICBC high-rank officials concerning the day-to-day operations of such a big company.

The meeting was long discussed about afterwards, and every participant remembered it, also thanks to the great gifts they had received.

NATIONAL MUSEUM OF WARSAW

The penultimate attraction was the high time to get a break from highend business and law issues, and engage in cultural development. THE OPENING CONFERENCE OF THE BEIJING PART

Monday, October 29th

Official opening of the Fifth Edition of the Warsaw Beijing Forum took place in the conference hall of the BUPT Hotel. Not only participants of the project attended the conference, but also representatives of our partner universities. The ceremony began with the opening speeches delivered by:

Tuesday, October 30th



KING & WOOD MALLESONS LAW FIRM

The first lecture of the Forum was held at the headquarters of King & Wood Mallesons. In the beginning, the students were introduced to the history of the company. They were also informed about the main areas in which a law firm operates, such as Corporate M&A, Securitised Capital Markets, or Banking & Finance. The participants were given hands-on advice on how to get a job as a lawyer and a profound insight into one's everyday job by Mr Xi Li, a partner at the firm. Afterwards, the students heard the details concerning professional background of Mr Shi, Partner at King & Wood Mallesons. Then, a Q&A session followed, during which students asked multiple questions, mainly about the company's future targets.

Wednesday, October 31st



EMBASSY OF POLAND IN BEIJING

On the second day, participants of the Fifth Edition of Warsaw-Beijing Forum were invited to the Polish Embassy in Beijing. During the trip around the office area, students learned that this embassy is one of the biggest in China. Later, they learned about how many Polish students are currently gaining knowledge at the University of Beijing, and got an insight into the reality of getting an internship in China.

THE SUPREME PEOPLE'S COURT

By courtesy of the Beijing team, guests from Warsaw had an honour to visit the Supreme People's Court, the highest level of court in the People's Republic of China. The meeting enabled them to gain information about supervising the trials of both local and special people's courts at different levels, but also about offering explanations over the actual application of laws during the trial process.





MEETING IN DENTONS LAW FIRM HEADQUARTERS IN BEIJING

By courtesy of Mr Xugang Yu, a senior partner at Dentons branch in Beijing, students attended a lecture about M&A in China. It was followed by a Q&A session, during which they were able to obtain detailed information about outbound deals, private equity and venture capital fund-raising. Warsaw guests also had the pleasure to get a tour around Dentons office.

THE BEIJING PART

Thursday, November 1st



SINA.COM HEADQUARTERS

On the third day of the Forum the guests were invited to the headquarters of the Sina.Com - Chinese technology company that operates major business line such as Sina Weibo. Students gathered information about working environment of the company while visiting the splendid office area. They got a rare through-the-keyhole look into the company's everyday operations.

BEIJING HUAYUANDIAN INFORMATION SERVICES

During this meeting, the participants of the project had an opportunity to learn about the usage of artificial intelligence in collecting Big Data. The lawyers introduced students to the theoretical and practical nuances of the functioning of Al., which was showcased by specific examples of Google's Translator or Amazon system of preferences. Students realised that Al concepts and notions which sounded like a science-fiction at first glance are today's reality and learned how to embrace them.



Friday, November 2nd



BEIJING ENAMEL FACTORY

On the fourth day of the Forum, the guests had the pleasure to visit Beijing Enamel Factory. First, they were presented with a brief history and description of the art of Cloisonné. Members were not only amazed by the professionalism and level of experience of factory workers, but also fascinated by the craftsmanship and striking beauty of these pieces of art.

CLOSING CEREMONY AT LONGAN LAW FIRM

During the visit to Longan Law Firm, the participants gained much information about one of the oldest partnership law firms in China. Established in 1992, Longan Law Firm's work field mostly concentrates on developing and fostering innovative legal structures for a wide spectrum of business transactions including, but not limiting to, capital markets, private equity, project finance, mergers, acquisitions and intellectual property. The participants took a tour around the office area.

Afterwards, they attended official closing ceremony, which took place in the Longan Law Firm's seat.



VISIT TO HONG KONG

November 5th - 6th 2018

DAY 1 MEETING WITH CONSUL GENERAL

The series of meetings started from a high note - the participants had a pleasure to meet with Polish consul in Hong Kong – Mirosław Adamczyk. He introduced students to duties and responsibilities of consul work. The students were also presented with essential information about law and economy of the Special Administrative Region of Hong Kong.

DAY 2 CLIFFORD CHANCE LAW FIRM HONG KONG BRANCH

The Warsaw-Beijing Forum members visited Hong Kong branch of Clifford Chance law firm. Representatives of Clifford Chance gave a lecture about One Belt One Road Initiative and Hong Kong's place in it. Students also got an opportunity to get more information about arbitration in Hong Kong, which is the most popular way to resolve disputes outside the court in China.

CMS HASCHE SIGLE HONG KONG BRANCH

In this year's edition, the participants of Warsaw-Beijing Forum had a chance to visit Hong Kong branch of CMS law firm. The hosts gave an indepth lecture about how to get permission to become a lawyer in Hong Kong - a process which may sound incredibly complex, but was made clear and understandable by the speakers. Furthermore, they introduced the listeners to how a day in the life of Hong Kong lawyer looks like.
