DR JAKUB JAKÓBOWSKI, CENTRE FOR EASTERN STUDIES

Dr Jakub Jakóbowski is a Senior Fellow at the Centre for Eastern Studies (Ośrodek Studiów Wschodnich). Analyst in the Program of the Chinese Center for Eastern Studies. Graduate of the Institute of Ethnology and Cultural Anthropology of the University of Warsaw (UW) and the International Economic Relations at the Warsaw School of Economics (SGH). In October 2021 he received his PhD from the Economic and Social College of the Warsaw School of Economics, after defending a doctoral dissertation on the subject of China's foreign economic policy towards developing countries. Taiwan Fellowship holder at Taipei's Soochow University, lecturer at postgraduate studies at the University of Warsaw and the Warsaw School of Economics. In 2012–2015 he worked in export consultancy for the Polish SME sector, on the markets of East Asia and the CIS area.

BARTOSZ KOMASA

Bartosz Komasa has been dealing with Polish-Chinese economic relations for 15 years. He started his work by providing services to Polish companies at the Economic and Trade Department of the Polish Embassy in Beijing. From 2004 to 2012, he worked at the Polish Information and Foreign Investment Agency (PAlilZ), where he was responsible for Asian investors. He ended his work at PAlilZ as a Section Manager for Far East. Bartosz Komasa specializes in training on intercultural differences, negotiations and foreign investments. He conducts workshops on entering Asian markets based on local socio-economic conditions and cultural differences, business etiquette and the specificity of savoir-vivre. For 10 years Bartosz Komasa has been training local governments' officials in the field of diplomatic protocol and attracting investors from Asia.



Practical information

Graduation requirements

Attendance: 2 unexcused absences per semester are acceptable (full absence is regarded as not being present on the whole teaching session; partial absences add up)

Mode of studies: Teaching sessions are held on Saturdays. The classes usually start at 8 AM and finish around 2:30 PM. Optional classes might be organised during weekdays. If so, attendance is not mandatory. Students should have their cameras turned on during the lectures.

Language of instruction: English. Students are asked to use English during the classes.

Memos: Students are asked to prepare half-page memos (summaries) based on one core reading material for every lecturer before each Saturday of classes. If the teaching session consists of two lectures delivered by two lecturers, students should write two memos (they choose two texts, get familiar with them and then summarize them in memos); if the teaching session consists of lectures delivered by one lecturer, students should write one half-page memo. The main rule is: one memo for every lecturer.

Completing the course: The final evaluation is based on students' presence and activity during the classes and the quality of their memos. At the end of the academic year all students are provided with feedback on their writing skills. There is no final exam. If students wish to receive a certificate of completion with distinction (+ a very good grade - this applies only to students of the University of Warsaw), they should write an additional miniessay (up to 3 pages) in May 2022 and send it to us.

Graduates will be awarded a certificate of completion. Current students of the University of Warsaw will also be qualified to obtain 12 ECTS credits.

Reading materials

Reading materials will be provided by the lecturers of the School and sent to the students in advance via e-mail. Students are asked to read the materials before the classes.
